The nature of overnight tours often requires moderate walking each day, as well as adherence to a schedule. These tours are operated by Spirited Travel of Haymarket, Virginia. All transportation, sight-seeing excursions, attractions, restaurants, hotel accommodations or other travel services are furnished by them as agent for the contractors providing the services. Spirited Travel Tours is not responsible for acts or omissions of the Suppliers or their failure to provide services or adhere to their own schedules. Spirited Travel Tours assumes no responsibility for and shall not be liable for any refund, personal injury, property damage, or other loss, accident, delay, inconvenience, or irregularity which may be caused by: (1) any defaults, wrongful or negligent acts, or omissions of the Suppliers; (2) any defect in or failure of any vehicle, craft, equipment, or instrumentality owned, operated, or otherwise used or provided by the Suppliers; or (3) any wrongful or negligent acts or omissions on the part of any other party not under Spirited Travel's control. By utilizing the services of the suppliers, you agree that your remedy is directly with the suppliers and not with Spirited Travel. Spirited Travel tour programs are planned. If, between planning time and the actual tour operation, circumstances beyond our control require changes, we reserve the right to vary itineraries and/or substitute components of our tour programs. Spirited Travel reserves the right at any time to dismiss anyone from the tour whose conduct has become injurious to the welfare and pleasure of other tour participants. The dismissed person must make their own arrangements for return home at their expense. No tour refund will be made. If you choose to leave a vehicle at the departure point, you do so at your own risk. Neither Spirited Travel nor the owner of the parking lot will be responsible for any loss or damage to your vehicle. You acknowledge and understand that: (i) airlines can increase their prices at any time before tickets are issued and that Spirited Travel Tours has no control over issuance of tickets for tours; (2) airlines, cruise lines, tour operators, and other Suppliers have their own contracts covering cancellation penalties and other terms and conditions, and that you may be bound by those contracts regardless of whether you receive notice of their terms. In the event of an emergency, you give permission to tour escorts of Spirited Travel to accompany you to secure proper medical care as deemed necessary at the time. You hereby release Spirited Travel from all costs and liabilities incurred because of said medical care. You have received a copy of Spirited Travel' Terms and Conditions and understand how they pertain to your participation in any part of this or future tour programs and that Full and final payment for a reservation on a tour, and/or your participation in any part of a tour, constitutes consent to all provisions of these Terms and Conditions. You agree that the courts in Prince William County will be the exclusive jurisdiction for all claims brought by you or Spirited Travel Tours, and you hereby submit to the personal jurisdiction of those courts. For your protection, we require all tours include trip cancellation insurance. In addition, in case of an unforeseen medical emergency, you agree to have an insurance identification card with you on the tour. We also require that you use a credit card for your purchase, so that you can exercise your rights under the Fair Credit Billing Act if you do not receive the services you purchased.
